On January 15, 2026, the Company received a Section 107(a) imminent danger Order from MSHA due to a third party dump trailer driver exposed to a fall hazard by standing on the vehicle trailer ladder rungs at its RAVENNA cement plant, New York. No injuries occurred as a result of this incident.
